



To amend the Saipan Zoning Law of 2013, as enacted by Saipan Local Law 18-4, by repealing parts of the Saipan Zoning Law pertaining to the Adult Business Overlay Zoning District and to delete the designation of the Overlay District on the sheets of the Official Saipan Zoning Map.

BE IT ENACTED BY THE THIRD SENATORIAL DISTRICT DELEGATION
PURSUANT TO CHAPTER 4, DIVISION 1, TITLE 1 OF THE
COMMONWEALTH CODE:

Section 1. Findings. The Saipan Zoning Law of 2013, also referred to as Saipan Local Law 18-4, designates a long swath of land on Saipan as the Adult Business Overlay Zoning District. Covering prime real estate properties, mostly privately owned from the middle of Garapan Village to central San Jose Village along Chalan Pale Arnold, the overlay district is incompatible to numerous existing uses in the area that include residential homes, office buildings, churches, private schools and apartment complexes that have characterized the development of the Middle Road area. Private landowners have expressed their concerns about the impact of the overlay district on the quality of life and their ability to attract potential buyers, long term lessees, and even short-term tenants in light of the designation of the area in view that adult business may be established near their properties. Those concerns also raise an important policy question on the necessity of such a designation for such a significant piece of

1 prime real estate on Saipan. To maintain and encourage the continued development pattern in
2 the area, the Third Senatorial District Delegation finds that the public interest would be served
3 by amending the Saipan Zoning Law of 2013 to delete the designation of the areas described in
4 the law for the Adult Business Overlay Zoning District.

5 **Section 2. Amendment.** The Saipan Zoning Act of 2013 enacted by Saipan Local
6 Law 18-4 is hereby amended as follows:

7 (a) Section 513 of Saipan Local Law 18-4 is hereby repealed in its entirety.

8 (b) Section 103 of Saipan Local Law 18-4, "Definitions" is amended by deleting the
9 definition "**Adult Business Overlay Zoning District.**"

10 (c) The following provision is added: The term "**Adult Business Overlay Zoning**
11 **District**" is deleted wherever it appears in the Saipan Zoning Law.

12 (d) The "**Adult Business Overlay Zoning District**" designation is deleted wherever it
13 appears on Sheets 13, 16, 19, 20 of the Official Saipan Zoning Map.

14 **Section 3. Severability.** If any provision of this Act or the application of any such
15 provision to any person or circumstance should be held invalid by a court of competent
16 jurisdiction, the remainder of this Act or the application of its provisions to persons or
17 circumstances other than those to which it is held invalid shall not be affected thereby.


18 **Section 4. Savings Clause.** This Act and any repealer contained herein shall not be
19 construed as affecting any existing right acquired under contract or acquired under statutes
20 repealed or under any rule, regulation or order adopted under the statutes. Repealers contained
21 in this Act shall not affect any proceeding instituted under or pursuant to prior law. The
22 enactment of the Act shall not have the effect of terminating, or in any way modifying, any
23 liability, civil or criminal, which shall already be in existence on the date this Act becomes
24 effective.

1 **Section 5. Effective Date.** This Act shall take effect upon its approval by the
2 Governor or its becoming law without such approval.
